In this week's Parsha, we learn about the unique camels of Avraham. What was special about his camels? They were muzzled so that Avraham would not accidentally steal from other people's property if his camels would eat from their land.

Thai leads us to the following story. Zev worked for a company that gave their employees a company car to drive to meet their customers. The company's policy was that if the car would get a ticket for anything that was the company's fault, like an expired registration or broken taillight, then the company would cover any fines. But if the driver gets a ticket for something that was the driver's fault, like a traffic infraction, then the driver is obligated to pay for it. One day Zev was driving, and he did not pay

Zev sped by a police cruiser that was waiting in a thicket. The police quickly turned his lights on and, on the loudspeaker, told Zev to pull over.



IT IS NEVER ENOUGH

When Avraham instructs Eliezer to go to Charan to find a wife for Yitzchok, Eliezer raises the concern that perhaps the woman will not want to come. Avraham tells Eliezer not to worry; "HaShem Who took me from my father's house and promised to me that my children will inherit this Land, He will send his angel before you." Armed with the blessing of Avraham, Eliezer heads out to Charan. When he arrives at the city well he turns in prayer to HaShem and pleads to please grant him success in finding the woman who is destined for Yitzchok.

How are we to understand Eliezer's prayer? Avraham, the individual about whom HaShem said that he is the source of blessing for the entire world, gave him a blessing that HaShem will send His angel to insure that the woman will be found? What concern did Eliezer have that compelled him to daven for this special intervention?

Shmuel Tamir, Israel's Minister of Justice in 1977, was considering introducing a law in the Knesset legalizing abortion. As you might imagine, there was an uproar in many communities around Israel about such a prospect. How can we allow a law that permits indiscretionate abortion ? A large group of Rabbis organized and chose several Rabbis to speak to Mr. Tamir. Among the people chosen was Rabbi Michel Stern, the Rov of Ezras Torah and Rav Raphael Levine, the son of Rav Ar-yeh Levine. The latter was chosen because his great father, Rav Aryeh Levine was revered even in non-religious circles.

A few days before the scheduled meeting, Rabbi Levine sent an urgent request to all the Rabbonim to please do whatever they can in having their communities pray for the success of their mission. So much was riding on this meeting they needed tremendous syata d'Shmaya.

SHABBOS: CELEBRATING HASHEM'S CREATION MEXICAN MOLE LIZARD

Recently in Parshas Bereishis, we learned about the nachash, the primordial snake that caused Adam and Chava to sin. Our Sages teach that the original nachash had legs. Today it is hard to imagine a snake with legs. But there is a mysterious creature that looks just like a snake with two front legs. Please meet the Mexican mole lizard.

The Mexican mole lizard is also known as the 5-Toed Worm Lizard. It is called this because it has five toes on each foot. It is part of the Bipedidae family. Bipedidae means bi ped, two feet. That is because this unique species only have two feet. It is one of the most unique creatures in the animal kingdom. It is endemic to Mexico's Baja California region.

It measures almost ten inches long and about a quarter of an inch wide. They live to be only one to two years old. Mexican mole lizard looks like a hybrid of an earthworm, mole, and salamander.

It has a blunt head, a slender, ribbed, pink body reminiscent of a giant earthworm, and two tiny forelimbs that it uses to burrow underground, which reminds us of a mole.

Mole lizards live underground, close to the surface, and only emerge at night or after heavy rains.

Its skin is closely segmented like earthworms. It uses the same method as the legless earthworms to move underground. It movies underground with a process called peristalsis, which is the symmetrical contraction and relaxation of its segments. Its blunt head allows it to burrow into the soil efficiently.

Its skin color can vary slightly from pale pink to bright pink. Sometimes the colors can be more gray-toned than pink. The reason why the colors are usually very light is that it lacks melanin, skin pigmentation, from living underground. Melanin is usually produced by exposure to the sun. Scientists believe that the light color of these lizards helps them do a better job of blending into the environment and hiding from predators and their prey.

Most lizards, in general, have very sensitive ears with delicate eardrums. The Mexican mole lizard, however, does not have ears. Scientists have observed that the lack of ears helps it dig into the soil more efficiently. If so, how does it hear? Hashem designed it so that its entire skin acts as an ear, and the skin can transmit vibrations to the cochlea, the inner ear.

The Mexican mole lizard has two legs in the front. They are short, strong, and paddle-like. It has no legs in the back. Its tail is autotomous. This means that it can shed or discard its tail as a self-defense mechanism to elude a predator's grasp or to distract the predator and thereby allow escape. It also uses this for another clever strategy. Sometimes it loses a part of the tail while burrowing down, so it plugs up the hole behind it, preventing the predator from entering the hole and giving it time to escape.

However, if it discards its tail, it cannot regenerate, unlike a gecko, which can regenerate its tail and other limbs. Interestingly, even after the tail is removed from the body, the tail can still move. Snakes are the most common predators of mole lizards.

What does the mole lizard eat? It is a carnivore and eats ants, termites, ground-dwelling insects, larvae, earthworms, and even small animals, including other lizards. It mainly feeds on easily accessible prey found in soil, debris, and dirt. When it catches prey, it usually pulls its prey underground to start its meal. We know that some snakes swallow their prey whole. But mole lizards are not like snakes. The mole lizard bites and chews its prey rather than swallowing it whole.

When mole lizards breed, they lay their eggs in the soil underground. The female lays between one to four eggs. It takes about two months for the eggs to hatch. The eggs hatch in September, and when the baby lizards emerge, they weigh less than one ounce. Immediately after birth, the hatchlings already know how to burrow and can burrow through the soil.

Snakes can bite, but do Mexican mole lizards bite? Not really. Though the lizards have teeth, they rarely bite. Those bites should not cause pain or discomfort because their teeth are so small. You can usually grab the lizard's head with two fingers and carefully pry its mouth away from your body without hurting you or the lizard. These lizards are also not poisonous and are safe to touch and handle. Thank you, Hashem, for your wondrous creation!


JUST AS I AM NOT PERMITTED TO SMOKE ON SHABBOS I AM NO LONGER PERMITTED TO SMOKE ANY DAY

If a doctor would tell Rav Baruch Ber Liebowitz (pictured, top) to do or not do something for the sake of his health, Rav Baruch Ber would comply without hesitation. Once, when a doctor told him to not eat a certain food, for it was not good for him, Rav Baruch Ber told his family that because it was a question of his health, that particular food now was forbidden to him "like treif meat".

There is a similar story with Reb Yaakov Kamenetzky. At one point, a doctor suggested that Reb Yaakov lose some weight and he prescribed a diet. At Reb Yaakov's next checkup, the doctor was shocked to find that he was losing weight too rapidly. When R' Yaakov insisted that he had followed the diet precisely, the doctor admitted that he had never met anyone who did not cheat on a diet, and had therefore told Reb Yaakov to eat less than he was really supposed to. By following the doctor's exact orders, Reb Yaakov had taken off too much weight.

Reb Yaakov used to smoke cigarettes and a lot of them. However, once the Surgeon General came out with the decision that smoking is hazardous to one's health he stopped immediately. "Just as I am not permitted to smoke on Shabbos I am no longer permitted to smoke any day."

Please note that of course, a caterer has a right to stipulate in the initial contract that if extra guests come, the groom is required to pay for it.
